Mr Thankanhu had reported that the Online Portal is already available in the College website since 2012. And that the portal is secure in such a manner that the individual submitting any kind of Grievance may not be identified by the general public.

After long discussion on the matter and brief study of the subject we come to the following conclusion & resolution -

1. The existing 'Anti-Ragging & Grievance Cell Committee' should be read in future as 'Collegiate Student Grievance Redressal Committee' (CSGRC)
2. As notified by the UGC notification, the

Chairman of the said Committee will be the Principal of this college. He will appoint three senior member of teaching faculty to be a member of the committee and one special invitee from amongst the student to represent the student of the college.

3. The term of the members and the special invitee will be for a period of 2 years.

4. The committee had also discussed the points to be included in the Prospectus of the college. The Principal had mentioned that whatever is in the notification must be uploaded in the college website from time to time and to make necessary alteration as and when required. This responsibility rests upon our college web-master Mr. T.K.A.

The committee is convinced that the UCG notification committee for college students include Grievance as well as Ragging.

Point by point clarification of the notification is presented by the chairman of the committee and the same pasted in Page - 25 - 28 of this minute book.
