

Purpose

2. The faculty of Computer Science Department, GZRSC will give a lecture based on the IT related subject of Commerce Department, GHBC.
3. The faculty of Commerce Department, GHBC will give a lecture based on the commerce related subject of Computer Science Department, GZRSC.
4. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Terms

This Agreement will become effective upon the date of signature by both Parties.


- 1) It shall remain valid for a period of three (3) year from the date of the last signature, with the understanding that it may be modified or extended by written mutual consent of both Parties.

ii) This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days.


iii) The agreement may be extended by mutual consent of the two Parties after the one-year period, and it must be renewed in writing.

MEMORANDUM OF UNDERSTANDING FOR ACADEMIC AND SCIENTIFIC COOPERATION

Between

Govt. Zirtiri Residential Science College, Aizawl, Mizoram.

&

Zonun Mat Ply (P) Ltd., Aizawl, Mizoram.

The purpose of this MoU is to promote cooperation in academic and scientific research between Govt. Zirtiri Residential Science College and Zonun Mat Ply (P) Ltd.

CLAUSE 1

Scope of the MoU

Through this memorandum, both Parties affirm the value of collaboration and agree to promote the following activities:

- 1.1 Research projects in fields of mutual interests;
- 1.2 Industrial Visits: Zonun Mat Ply (P) Ltd. will permit the faculty and students of Govt. Zirtiri Residential Science College to visit the company's factory at Lengpui for the purpose of academic and scientific research.
- 1.3 Other activities as mutually agreed.
- 1.4 This MoU places no financial obligations or supplementary funding commitments on either Party.

CLAUSE 2

Intellectual Property:

2.1 Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either party any right, title, interest or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other party.

CLAUSE 3

Relationship between the parties:

3.1 It is expressly agreed that the Parties acting under this MoU are independent contractors and the relationship under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or to create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

CLAUSE 4

Validity:

4.1 This Agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of two (2) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties.

4.2 This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. Upon notice of termination both Govt. Zirtiri Residential Science College and Zonun Mat Ply (P) Ltd. agree to work in good faith to enable visiting scholars to complete their respective research programs unhindered by the termination.

4.3 The MoU may be extended by mutual consent of the two Parties after the two-years period, and it must be renewed in writing.


