Respected Sir,

First of all, we take this opportunity to convey our heartiest greetings for your efforts in providing opportunities to the youth of Mizoram to come to the mainstream.

As you may be aware, The Institute of Company Secretaries of India is a premier national professional body constituted under an Act of Parliament (Company Secretaries Act, 1980). The Institute functions under the jurisdiction of the Ministry of Corporate Affairs, Government of India. ICSI has been set up to regulate and develop the profession of Company Secretaries. ICSI has its Headquarters at New Delhi and 4 Regional Councils at Chennai, Kolkata, Mumbai & New Delhi and 72 Chapters spread all over India.
